At the outset the General Secretary JUTA Dr. Virender Koundal welcomed the worthy members of the Executive Council. He apprised the members about the agenda of the emergency meeting and stated that the Fifth Executive Meeting held on September 15, 2014 wherein it was unanimously resolved that JUTA members will neither going to supply any information as per the format supplied by the District Election Officer, Jammu and same was communicated to the Registrar by letter No: JUTA/14/9/12 Dated: 15/09/2014 but latter on JUTA Fraternity was surprised to see their names on the website of District Election Office, Jammu.

On 26/11/2014, Office Bearers along with the faculty members of Jammu University had shown strong resentment over this issue and submitted a representation (No:JUTA/14/11/1 Dated 26/11/2014). It was conveyed that JUTA member will not attend the election duty which was scheduled to be held on 30/11/2014.

The members of the Executive council unanimously resolved the following

1. Firstly, JUTA demands to the Administration of the University to provide all the details of communication to the office of the District Election Officer /Deputy commissioner, Jammu
2. The members of the Executive Council showed great concern over providing wrong information to the District Election Office /Deputy Commissioner, Jammu. JUTA, condemn this act of negligence and demands action against those responsible for the same.
3. The members of the executive council unanimously resolved that if any action is taken against any teacher by the authorities for not performing the election duty JUTA will go on indefinite strike immediately.

The meeting terminated with a vote of thanks by the Dr Vivek Sharma Joint Secretary JUTA.
